What is Mansionization?

Many of our neighbors are greatly concerned about property development in our area. The character of our historic neighborhood is being fundamentally and irrevocably changed - and our quality of life diminished - as a result of the trend known as mansionization.

‘Mansionization’ generally refers to demolishing smaller, more historic single family homes and replacing them with new out-of-scale ‘big-box’ homes that dwarf surrounding dwellings and change the character and scale of established neighborhoods. In response to public concern, the Baseline Mansionization Ordinance was enacted in 2008 to stop widespread mansionization of

established single family Los Angeles neighborhoods. Despite this ordinance, mansionization has continued – largely due to loopholes, bonuses, and exemptions written into the ordinance. A recent *LA Times* article found that city-approved teardowns were 29 percent higher in 2013 than in 2012, a general indicator that mansionization is on the rise.

Other neighborhoods have undertaken ‘anti-mansionization’ efforts such as:

- petitioning to amend the (city-wide) Baseline Mansionization Ordinance to eliminate the often-abused bonuses and exemptions, and to make the internal review and enforcement processes of the Department of Building Safety transparent to the public
- requesting a Residential Floor Area (RFA) Overlay District in the R1 areas, reasonably tailoring citywide size and height regulations (for single-family homes) to the particular needs of a community

Neighbors wish to preserve the unique character of our area and to protect our quality of life by engaging and mobilizing residents around these issues. While we have no general objections to construction, expansion, or remodeling, we believe that new and remodeled homes should have *reasonable* size limits in proportion to the existing houses and lot sizes in our area.

We would like to see the Baseline Mansionization Ordinance amended (to eliminate loopholes that allow mansionization) and wish to solicit community opinion as to whether we should also request a Residential Floor Area (RFA) Overlay District in our R1 areas.

Please attend this critical meeting on March 10, to express your opinions! While we encourage you to walk or carpool, a limited amount of overflow parking is available at Burger King. Perhaps neighbors who park at Burger King will stop in for a soft serve ice cream or a meal either before or after the meeting, to express our thanks for their support.

Getting LA Back 2 Work

A Training, Retraining and/or Job Placement Initiative

City of Los Angeles Economic & Workforce Development Department

The "Getting LA Back 2 Work" program is funded by a National Emergency Grant under the Department of Labor. This grant targets displaced workers from specific public agencies and private companies identified from the Department of Labor. The grant provides qualified displaced workers with up to \$7,500 in training and placement support.

The City of Los Angeles is partnering with 18 WorkSource Centers located throughout the City of Los Angeles. Our goal is to identify 2,000 dislocated workers and get them enrolled, trained and placed in jobs by March 31, 2014.

Services include the following:

- Assessment (basic skills, career, and vocational aptitude)
- Customized training
(Up to \$10,000 of free training)
- Employment preparation
(resume and interview skills)
- Job/paid internship placement assistance
- Vocational training
- On-the-job training
- Supportive services (bus tokens, work clothes, tools, child care etc.)
